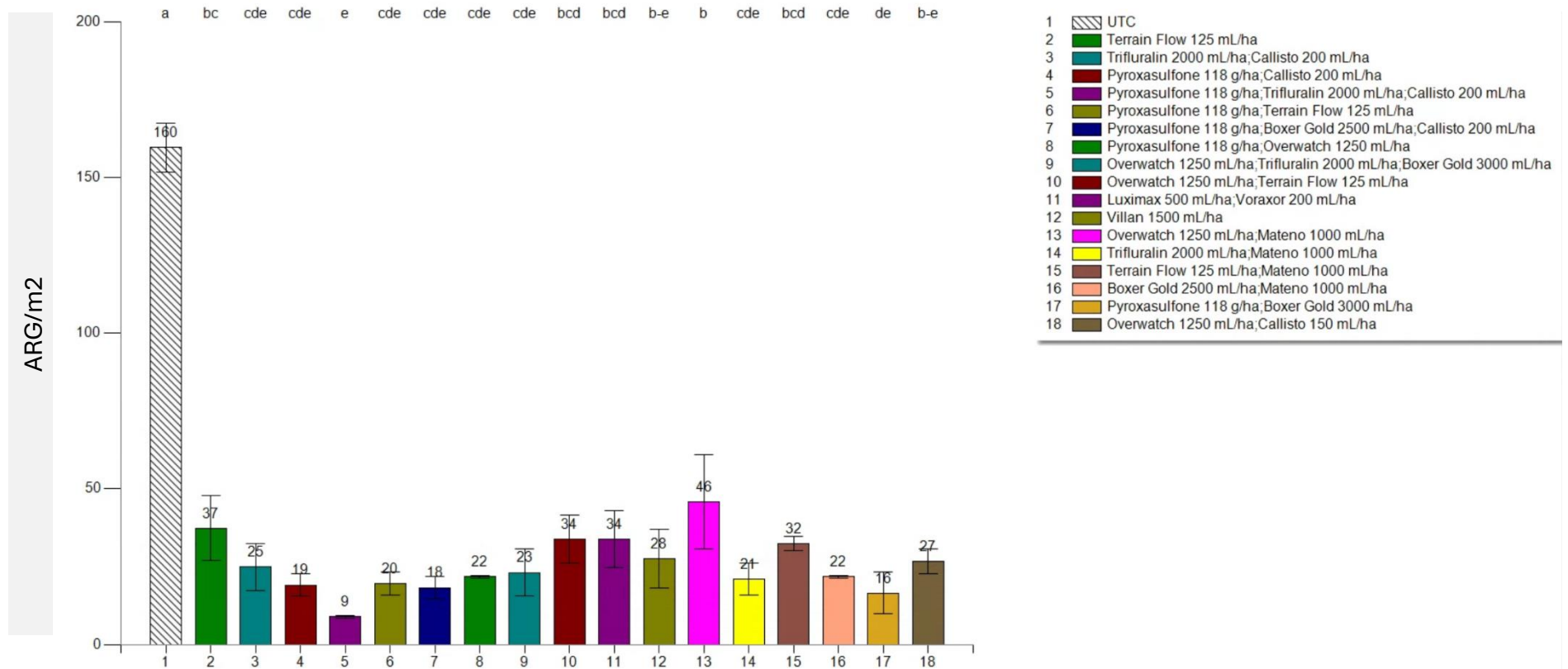

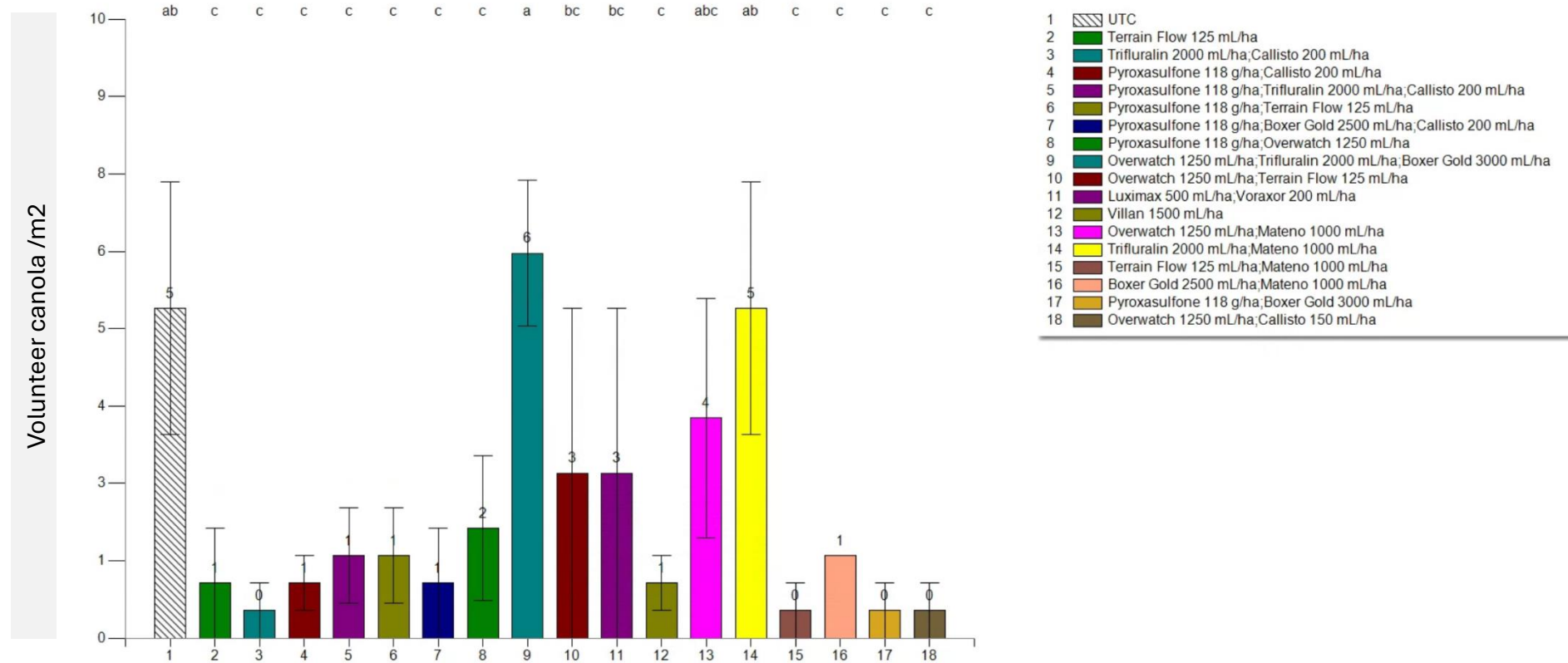

ARG counts per m2



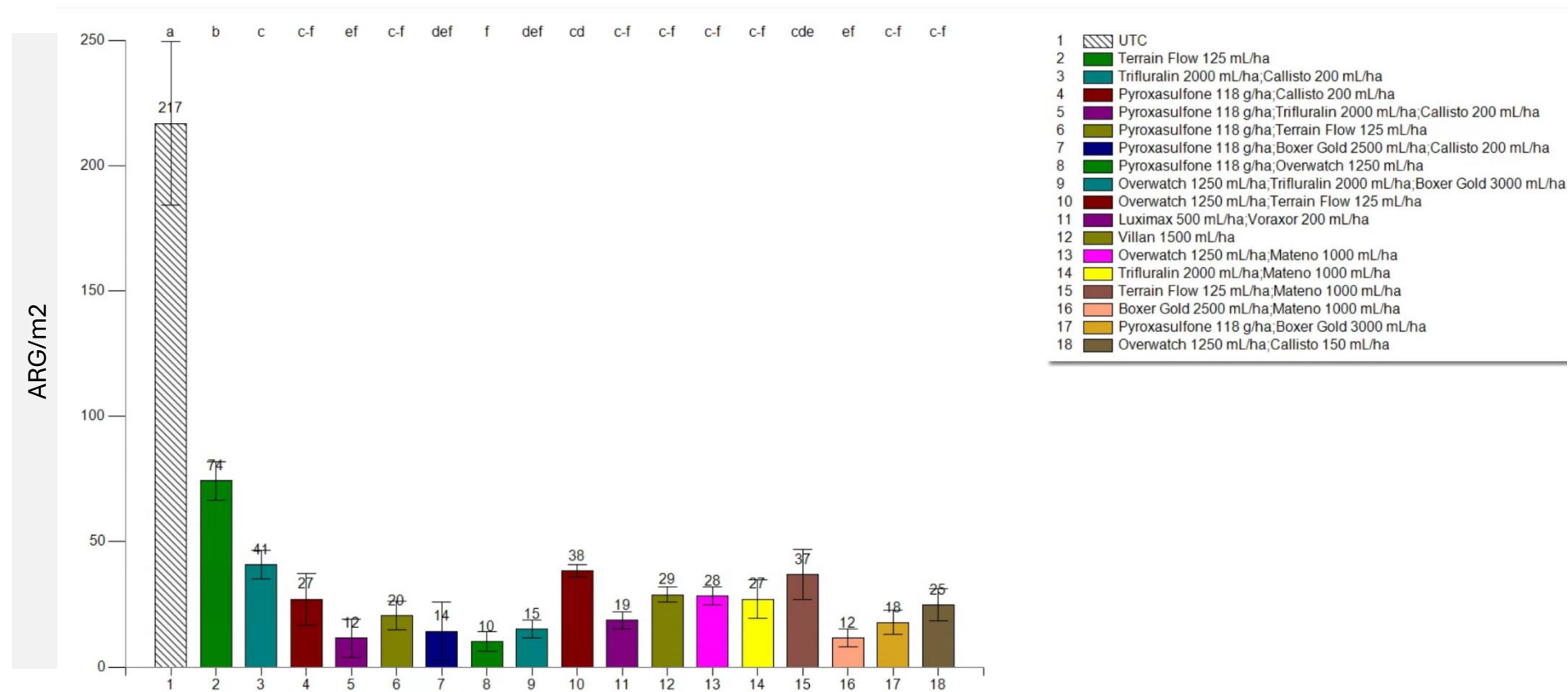

Volunteer canola counts per m2



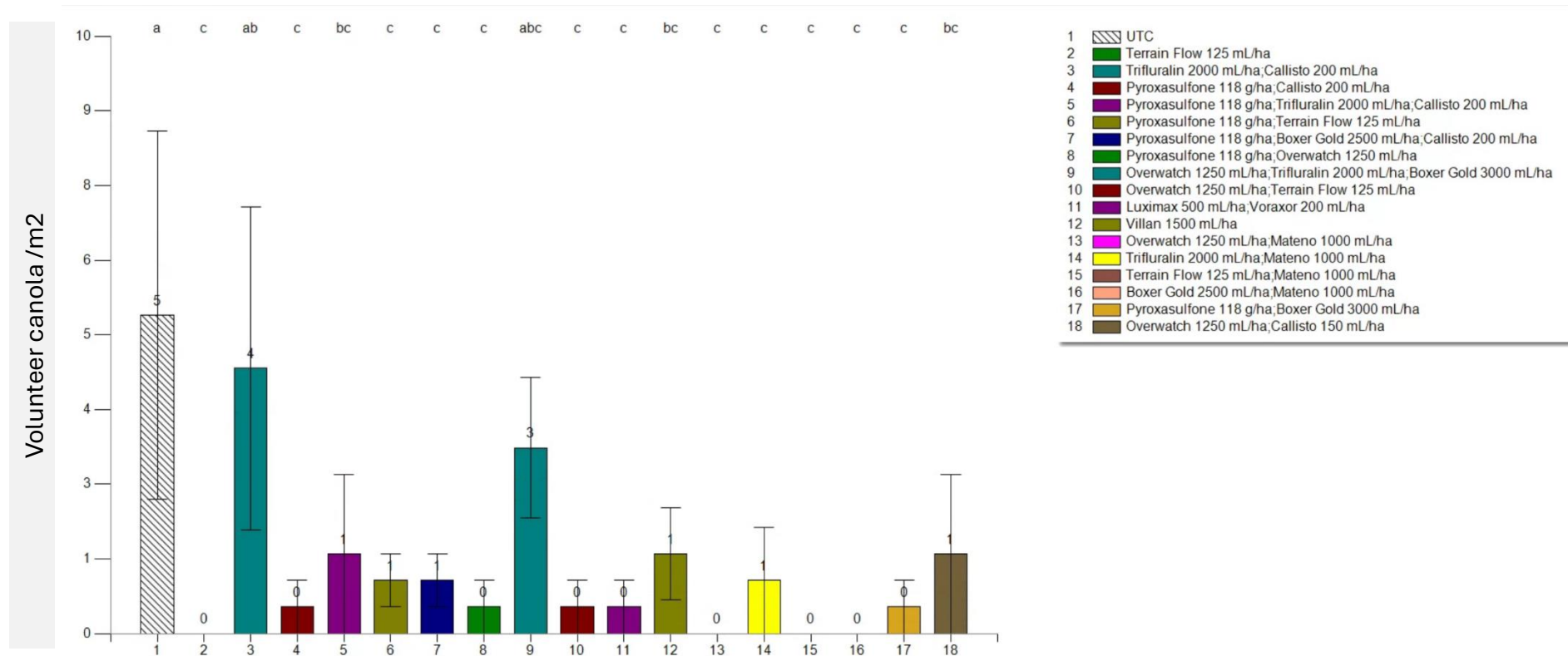

ARG counts per m2



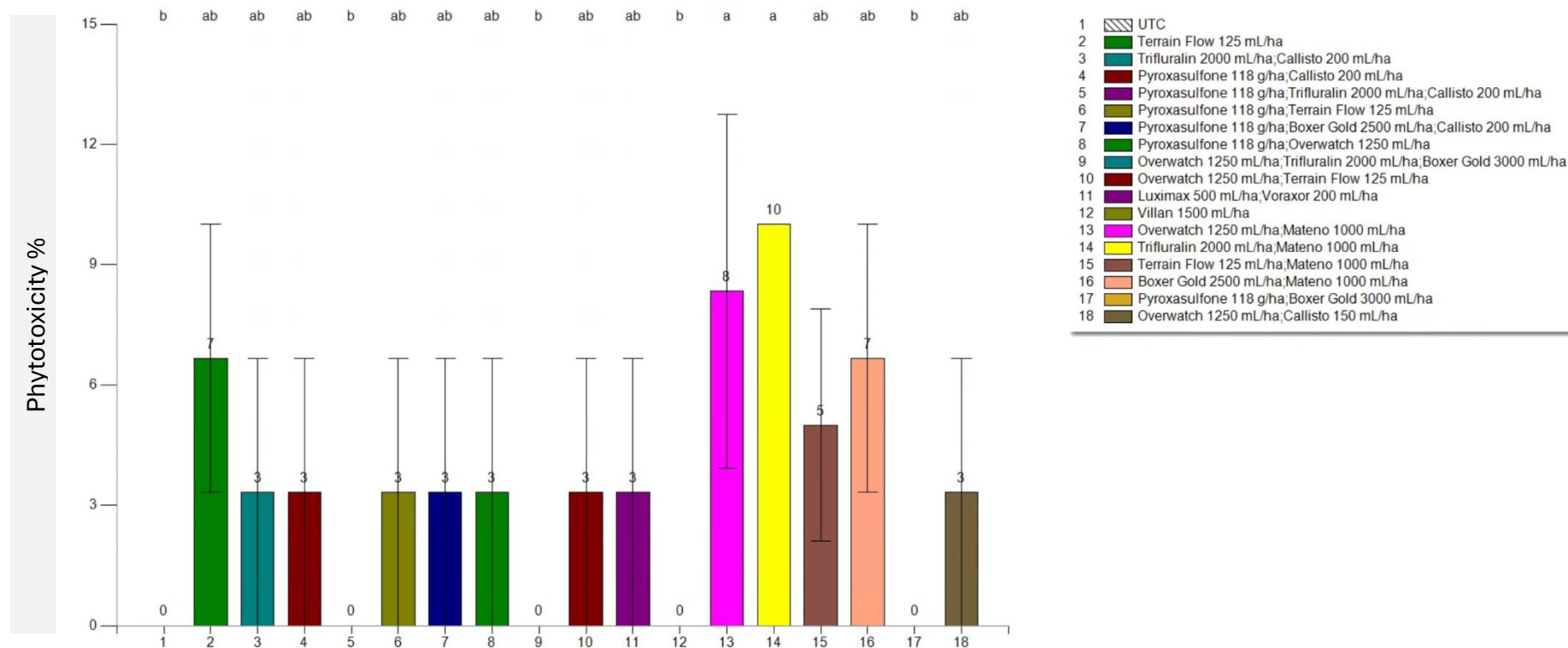

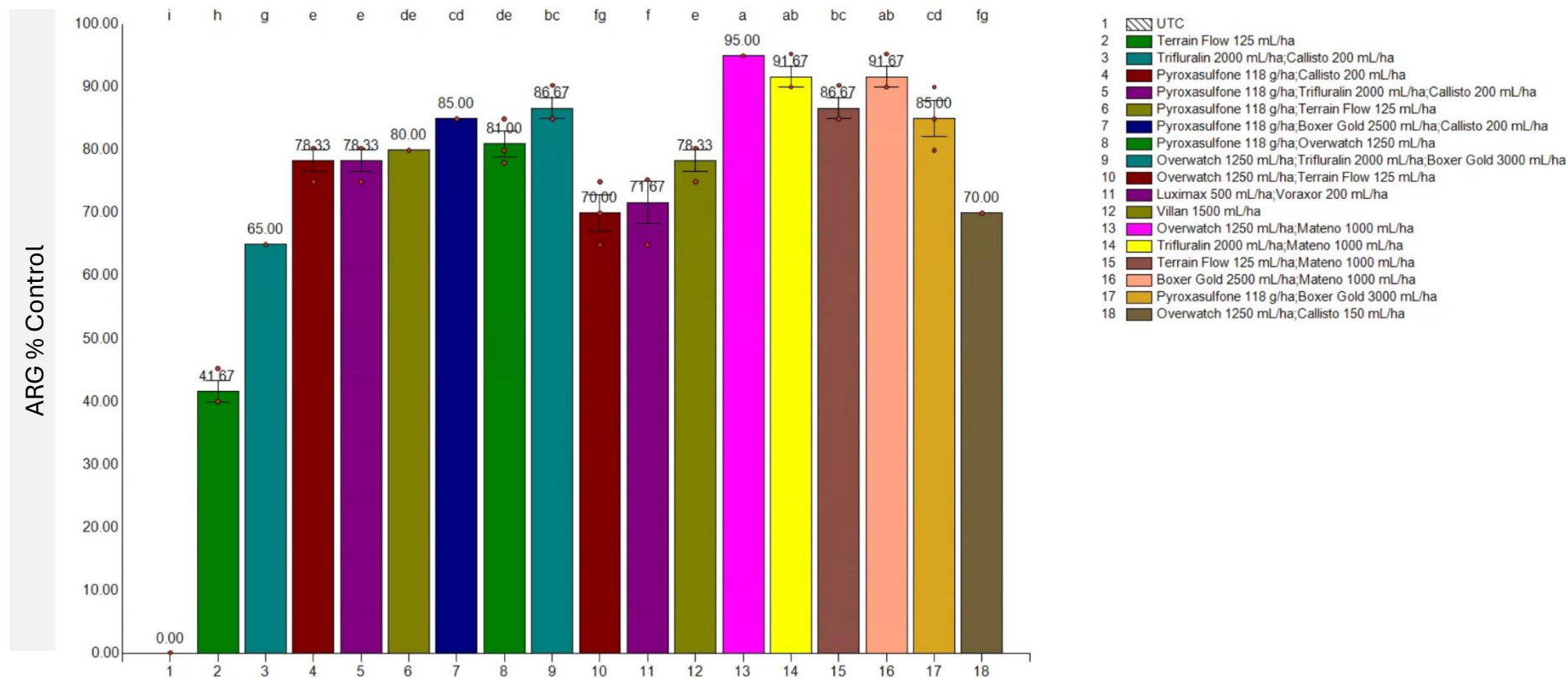

Crop Safety – Phytotoxicity



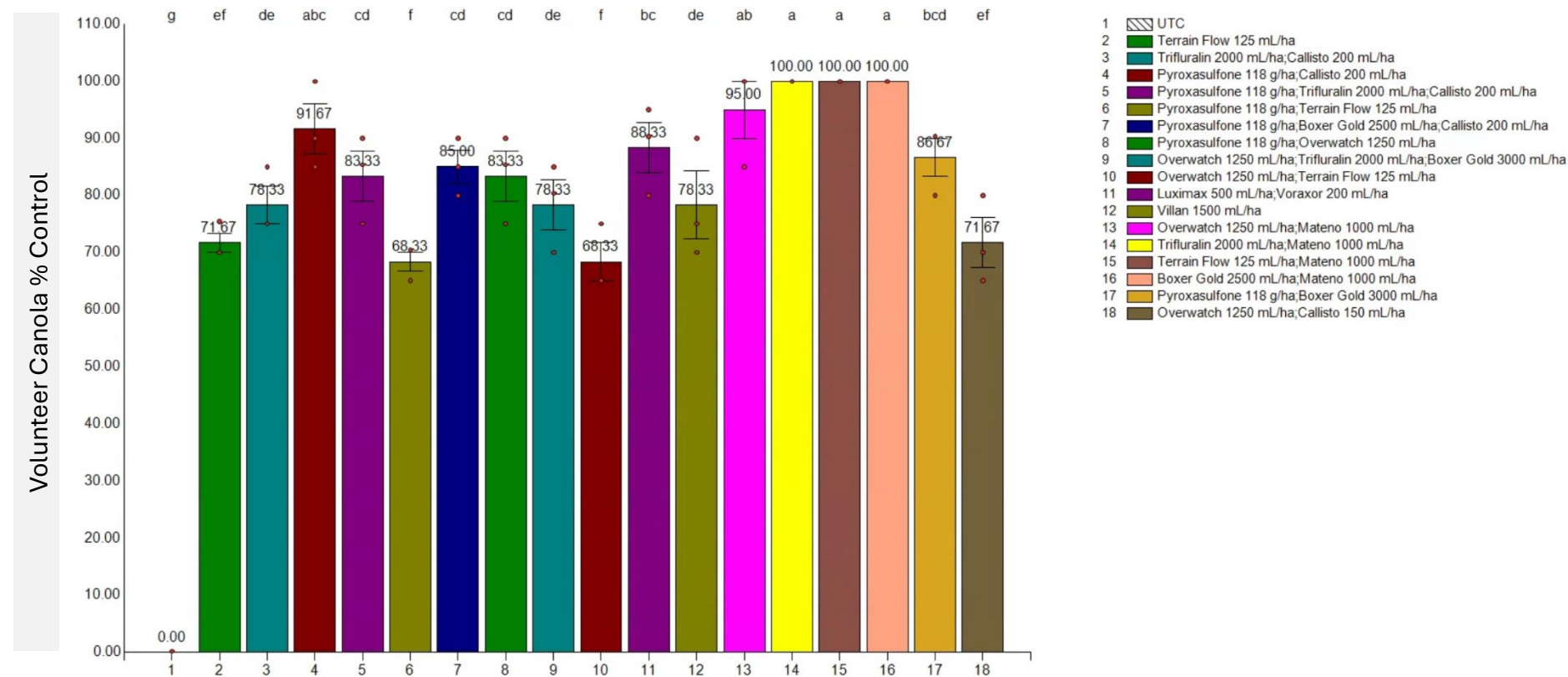

Annual Ryegrass % Control



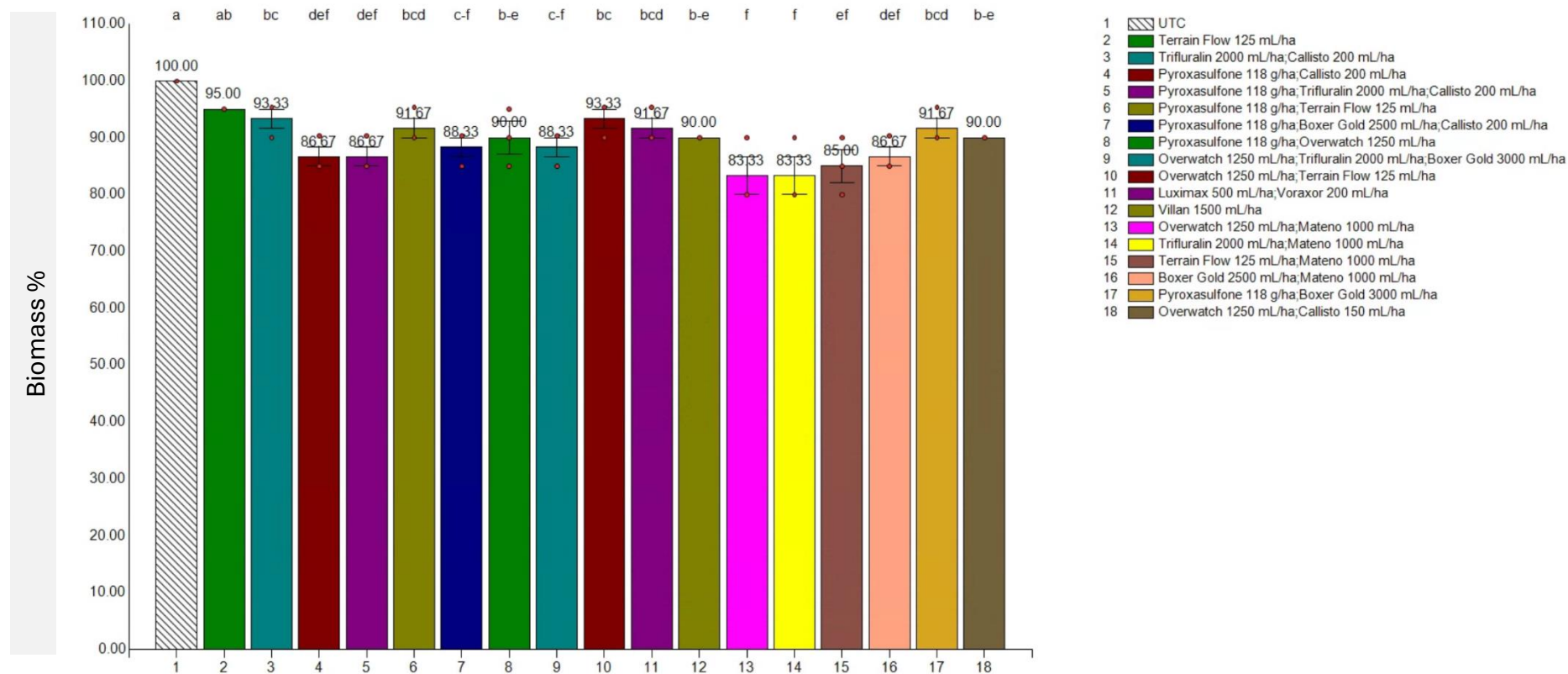

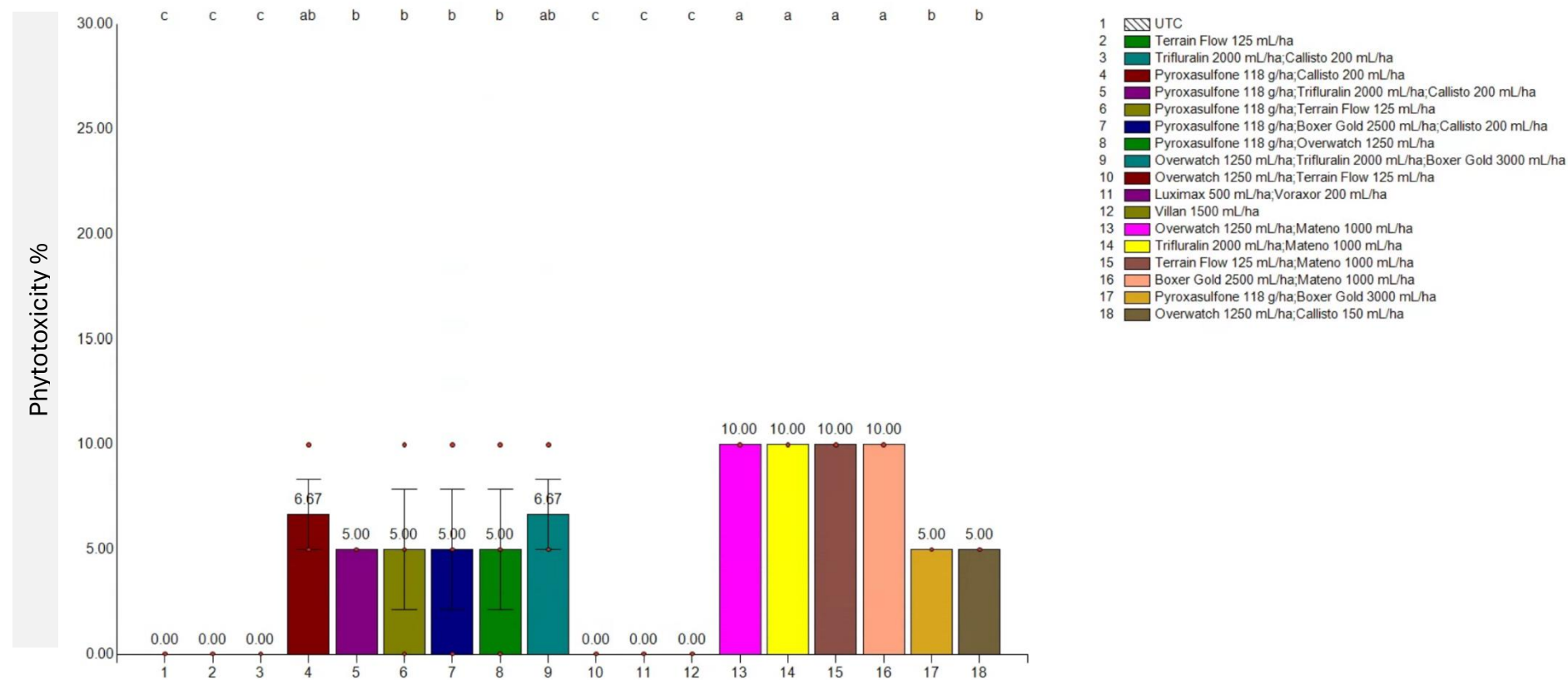

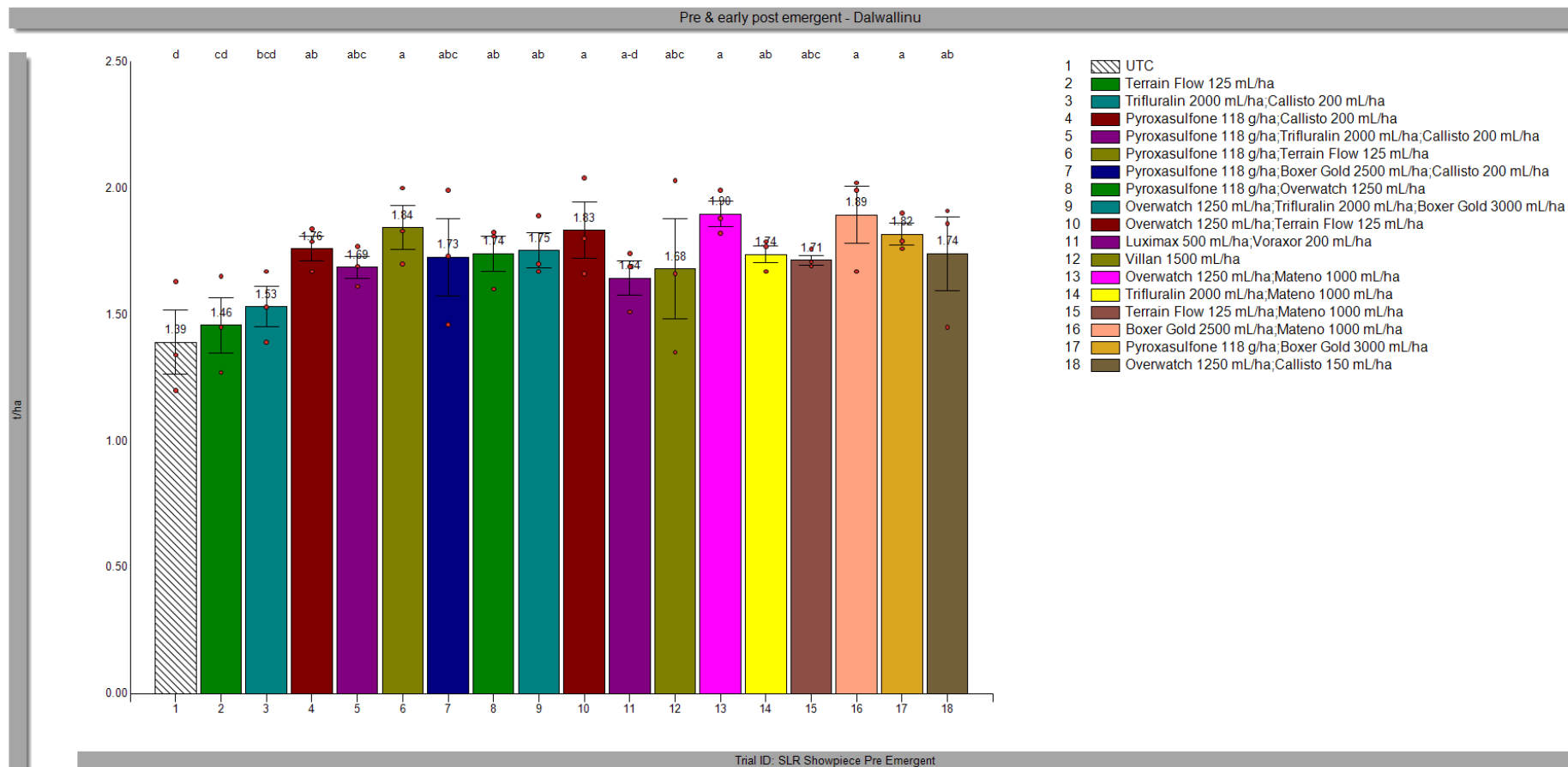
